PIISA collaborates with sister projects to boost dissemination of results

A lot is happening in the PIISA project this autumn. We are finalising research results. Some scientific publications have already come out and there are more in the pipeline. We have published info cards that summarize our results and are organizing several events for different target groups.

Instead of working alone, we are collaborating with other projects working with related topics at an increasing pace. That way it

is possible to multiply the impact of our dissemination efforts. In September, PIISA organized together with the SWIFFT project and with contributions from three more projects a hybrid round table discussion and seminar on adaptive forest management and policy. We held a webinar on wildfire modelling together with the Climate DT project in November. We are preparing a third roundtable discussion for policy makers together with the CilmateFit project related to urban greening, finance and insurance in December.

We are now drafting policy recommendations and a white paper for the insurance sector. The PIISA Policy Brief will be published on February 5th, 2026. The same day five projects will have a common policy session in Brussels as part of the NATURANCE festival. PIISA is taking part in organizing this session.

Together we are stronger.

1. Wednesday, February 4 from 9:30 to 11am “From Risk to Resilience: Insurance Solutions”

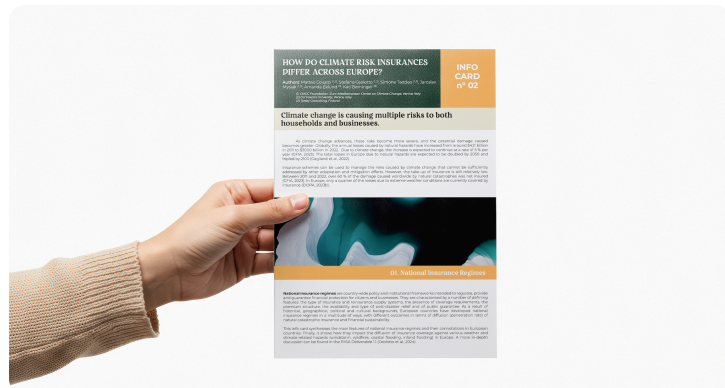

Don't sit on your data - make more of it through smart cooperation

The latest blog article, written by project partner Adriaan Perrels from Tyrsky Consulting, was recently published on the PIISA website.

Through the article, he explores how impact data about realised climate impacts, for example indicating property damage, crop losses, wildfires, or hospital admissions, is crucial for developing climate insurances. However, even though sharing the data has many benefits for both insurance suppliers and customers, the availability of impact data is a problem. Policy actions are needed to promote data sharing to ensure development of insurance innovations that promote climate adaptation.
